Angela Moore Direct, a division of Angela Moore, Inc. ("Angela Moore") and the undersigned Angela Moore Direct Style Consultant ("Style Consultant") agree to the following terms and conditions of this Style Consultant Agreement ("Agreement"):

1) **Sale of Angela Moore Products and Recruitment Responsibilities:** I agree to promote and sell Angela Moore products to customers by holding style shows and share the opportunity with others as described in the Angela Moore Direct Training and Opportunity Guides, as amended from time to time. I will uphold, honor and protect the name and reputation of Angela Moore and sell its products in an honest, sincere and professional manner. I have also read and agree to abide by the Code of Ethics of the Direct Selling Association which sets forth the ethical principles and practices of our business.

2) **Commissions, Bonuses and Incentives:** I understand that I may be entitled to receive Commissions, Bonuses and Incentives as outlined in the Training and Opportunity Guides. As a Style Consultant, I agree to purchase from Angela Moore its demonstration style kit of products and agree to sell Angela Moore products on terms and prices outlined in the Style Consultant Training and Opportunity Manuals, but the company reserves the right to change commissions, bonuses and incentives with 30 days notice.

3) **My Duties as a Style Consultant:** As a Style Consultant, I agree to sell solely through style shows and not to sell Angela Moore products over the internet or for resale in any public, retail or service establishment. I will not sell, promote or demonstrate products made personally by me. I understand that I am permitted to generate sales and recruit other Style Consultants anywhere in the United States without any specifically assigned territory.

4) **My Role as an Independent Contractor:** I agree to serve as a self-employed, independent contractor. As an independent contractor, I will be conducting my own business and will be responsible for filing all personal federal, state and local tax returns and paying my own income and self-employment taxes. Regarding sales taxes, Angela Moore Direct will collect and remit the sales taxes to the appropriate tax authorities on my behalf.

I will not be treated as an employee for any purpose, including unemployment compensation, workman's compensation or any other employee benefit program. No contract of employment, agency, franchise partnership or joint venture shall be created or deemed created by this Style Consultant Agreement. With the sole exception of fulfilling sales orders, I have no power or authority to represent Angela Moore, enter into any contracts, or incur any debt, obligation or liability on behalf of the company. I further agree to indemnify and hold harmless Angela Moore from any liability or claim brought against the company due to my negligent or wrongful conduct and compensate Angela Moore for any and all relevant costs, including attorney's fees and court fees to defend any such claim or action.

5) **Angela Moore® Trademarks and Confidential Information:** I agree not to use, display or reproduce for any purpose Angela Moore trademarks, trade names and copyrighted materials without the company's prior written permission. Any other information provided to me (including but not limited to the Training and Opportunity Guides, marketing materials, price lists, etc.) is considered proprietary and confidential. Accordingly, I will not disclose or transfer any such Confidential Information to other persons or companies either during or after the term of this Agreement.

6) **Non-Solicitation, Non-Compete:** I agree not to solicit, call upon, compete for, sell to, or take away any of the customers, suppliers, advertisers, style consultants or employees of Angela Moore during the term of this Agreement and for the period of two (2) years after termination of this Agreement, either in the United States of America or anywhere in the world.

7) **Yearly Renewal fee:** I agree to have \$25.00 deducted from my commission check every year for my renewal fee.

8) **Other Terms & Conditions:** I am 18 years of age, and this Agreement is effective as of the date shown, shall have no fixed term and may be terminated by either party, with or without cause. This Agreement shall be governed and interpreted according to the laws of the State of Rhode Island and may not be assigned or modified unless in writing signed by both parties.
